

Our Perspective: The Fifth Commandment

Congregations all over our country and all over the world are handling and processing the current times we find ourselves in almost as many ways as there are churches! There are congregations, much like ourselves, who are deciding to continue to not gather in person for the time being. There are others who have decided to gather in person as if there is no pandemic happening. Then there are a variety of others who are deciding something in the middle: gathering with distancing, singing/no singing/less singing, masks/no masks/masks recommended but not required, outdoor services, radio services in the church parking lot, shortened services, and many, many more variations. This article is in no way a condemnation of how other congregations have elected to worship right now, nor is it an endorsement of their choices. It is merely meant as a reflection from your pastors to the people of Pleasant View.

Do we want to be worshipping back in church? Of course we do! We want to be belting out hymns played on the organ together; we want to be placing the bread in each of your hands at the Lord's Supper; we want to be sharing faith and giggles with the youngest (and oldest!) among us. So, why not? Why not do what we want? Why not claim "religious freedom" and lift up the "riskiness" of Christian worship that we know was always there anyway? Folks have certainly gathered to worship in other extreme circumstances. Why not now?

Well, there are many reasons, but the 5th Commandment has been on our minds these days. "You shall not murder." This probably seems extreme at first. Upon first thought it would be easy to not see or get the connection, but here's Luther's explanation of the 5th Commandment: "We are to fear and love God, so that we neither endanger nor harm the lives of our neighbors, but instead help and support them in all of life's needs."

Luther didn't see this as an extreme commandment talking about only the violent act of murder, but an overall command to do all we can to look after the total well-being of all who are our "neighbors" (that's everyone!) How does this apply today? It is unfortunately still not possible to gather without the risk of endangering the lives of our neighbors. Yes, we want to gather out of love for God and our desire to show that love through our worship. But, through this commandment God tells us how we can show that love: by not endangering others. Maybe it's not the way we want to show our love, but it's the way God asks us to.


Yes, this issue is unfortunately becoming "political" and you may be feeling pulled to take the "side" where your friends and family are, but we urge you to stand firm in your faith. Until we know harm cannot come to others through our worship, why willfully disobey our Lord's command—especially since we have technology that wasn't available for the trials of the past which allows us to worship in a way that still shows our love of God and love of neighbor? By the grace of God, we'll get through this together!

The following is a motion and vote through email dated July 23, 2020:

Motion: Pastor Bob Nowak moved to offer The Latvian Lutheran Church (LLC) a two-month credit on their rent, that would be applied to the months of August 2020 and September 2020. Effective October 1, 2020, The Latvian Lutheran Church is granted a 50% rent reduction for the duration of months that LLC does not use the PVLC facility for worship or functions. Upon the Latvian Lutheran Church's return to the PVLC Facility for worship/functions, they agree to resume paying the full agreed upon monthly rental amount. If the Latvian Lutheran Church were to return to the PVLC facility before October 2020, the 50% rent reduction would not be necessary, and The Latvian Lutheran Church would be responsible to pay the full monthly rental amount beginning with October 2020. If the duration of months LLC does not gather at PVLC exceeds what either party feels is a reasonable amount of time, the 50% rent reduction agreement may be revisited and renegotiated to better reflect the arrangement and needs.
