Happy 178th Birthday!

If people actually lived that long, would you be proud to share your age or keep it well-hidden?

Would you let your white hair shine (granting you would still have hair at that point) or dye it, either to appear younger or just for fun – red, purple, blue, rainbow colors?

Would you use all of the lotions, make-up, and injections that you could to look young, or would you wear your wrinkles proudly?

Well, (luckily...unluckily?) no one here is 178, though if we start adding all of our individual ages together we could probably get there quite fast! Our building isn't even 178 years old, but, we, as a congregation are...or will be really soon on February 26, 2022. When people are looking at our building, which is from the 60's with later additions added, they are astonished to learn that our congregation, the continuation of people of this community, is much older than that and has moved several times in all of those years. And, in the past 2 years, we have made another kind of move, one that hasn't been permanent, but has greatly shifted who we are and how we see ourselves nonetheless. Yes, we all have varying and different opinions on "virtual church," but as a community, we have been able to do it!

Over 178 years, this congregation has shown how it can pivot and shift as needed, time and time again. The congregation built a larger building when more space was needed, and then added to it when even more space was needed. Then, as less space was needed, parts of the building were rented out to keep them from sitting empty, in an effort to be good stewards of all that we have. And then, as covid shook the foundations of what we understood "gathering" to be, we are now able to pivot to a virtual setting as needed.

So many changes and yet God continued to be worshiped and served by the congregation who calls themselves "Pleasant View Lutheran Church" these days – which wasn't even our first name either, by the way.

In these days of continuing Covid, when we so long to return to "normal," may we remember that change was always normal. As our Council continues to assess and re-assess what is safe and responsible for us to do as far as in person gathers, remember that the work of the church has always been to assess and re-assess what is next for the people of God here, not to maintain the status quo at all costs.

May year 178 be just as full of life as year 1 was for the people who call themselves "Pleasant View" and may we face our next year with bravery, trust, and love.

Greetings PVLC family,

On behalf of the Church Council, I would like to thank Alan Zimmerman for his leadership as president. Alan has stepped down for personal reasons, and we send him our prayers and best wishes. Alan helped lead and guide our congregation during an extremely difficult time, and he did so with compassion. He also leaned on his background as a statistician, bringing an important and level-headed perspective when we faced difficult decisions concerning the COVID-19 pandemic. He also relied on his faith and his study of the Bible, something I will always admire.

As stated in the "Connected" email recently, we are looking for volunteers for the Church Council. While talking with some of you, I realized not everyone knows what being on Council entails: How much of a time commitment does it take? What are Council meetings like? I thought I'd share a brief overview.

First, any member is invited to attend Council meetings, which are held at 6:30 p.m., the third Monday of every month via Zoom. Meetings typically last two hours, but there have been some longer meetings during the pandemic as we discussed what is best for the congregation, our neighbors and organizations that use our building.


We start with a devotion and prayer and share good news – personal and about PVLC. The pastors (they currently alternate attending the meeting) share their reports, which for the past two years have largely included COVID concerns and our tenants, how we are maintaining connections with our members and community, getting feedback on new ideas, staffing and other important topics that come up over the month. We share committee reports from Outreach, Finance, Worship, Education and Facilities and discuss any issues that arise. We consider upcoming events and issues and end with the Lord's Prayer.

But most importantly, we try to do what is best for the congregation, including financially, and assist our pastors in nurturing our congregation's spiritual life. We do this through prayer and discernment. I have to say, we have very thoughtful, honest conversations. In four years on council, I've never heard a raised voice.

I hope this shines some transparency on council membership. Let me know if you have any questions. And please consider attending the church's annual meeting on February 13. Thanks and blessings!


